



The course structure

Our Small Animal Diagnostic Imaging Postgraduate Certificate is designed for part-time study and delivered through a combination of in-person teaching days and online learning. You will spend roughly 50% of your time learning with your peers at our outstanding facilities, and 50% on guided, self-paced online activities; giving you the benefits of both in-person and online education.

Practical workshops are a cornerstone of the programme, and we provide industry-leading equipment for these sessions, to ensure your learning experience is exceptional.

Personalisation is built into our Diagnostic Imaging Certificate; 25% of your time will be spent studying towards the elective of your choice, allowing you to shape your learning journey to suit your interests and ambitions.



Structure and learning

The course consists of two modules, equating to a total of 200 study hours per year (including self study). We also include a Professional Key Skills course (at no extra cost), which will provide you with the academic requirements needed to gain Advanced Practitioner status from the RCVS.

Module I

This module is divided into 15 core units plus an elective. The units are spread evenly across the first two years of the programme. Here's how it breaks down...

- › **Eight days of in-person teaching:** Including practical skills training, lectures, and interactive case-based discussions and activities.
- › **Seven online units:**
 - Delivered entirely online, featuring webinars, interactive activities, and live-streamed imaging rounds.
 - Online study is supported by the unit subject specialist, and a dedicated member of the BSAVA team.
- › **One elective:**
 - Choose an elective subject with two practical teaching days, guided online learning, webinars, and two days observing practice with a vet working within your chosen subject area.
 - You can choose between Enhanced Ultrasonography or Enhanced Cardiac Imaging.
- › **One written examination:** testing the knowledge you have acquired in Module I, prior to progressing to Module II.

Module II

A casebook is submitted at the end of the third year, this allows you to showcase your ability to work through cases logically, justify your clinical decisions and evaluate outcomes in the context of published literature. Here's what is involved...

- › **Eight case reports** make up the casebook. Designed to be completed by vets working in first opinion practice and don't require specialist equipment.
- › **Two reflective commentaries** focusing on the veterinary skills you have developed.
- › **Case diary:** a portfolio of specified images to demonstrate your skills in diagnostic imaging.

You will benefit from a dedicated casebook tutor to ensure you have the support you need.

Can you bring a dog?

Due to the Small Animal Diagnostic Imaging Postgraduate Certificate involving hands-on, practical-based sessions, we rely on students to bring their own dogs (or one borrowed from a friend or colleague) to certain practical days. We understand that this is not possible for everyone, but we ask anyone that is able to bring a suitable dog to do so. Animal welfare is paramount to us, so a dedicated team member will be present to look after your pets when they are not involved in practical exercises. Facilities

How to get started?

To enrol in the BSAVA Postgraduate Certificate:

- › Applicants must hold a veterinary qualification
- › UK based applicants must be on the RCVS Home Practising Register
- › Applicants based outside the UK must hold a veterinary qualification that would entitle them to register as members of the RCVS.
- › Applicants must have spent a minimum of one year in Veterinary Practice.
- › Veterinary surgeons who qualified in 2007 or later and who are based in the UK must have completed the RCVS Professional Development Phase (PDP) or Graduate Development Programme (VetGDP) before they can enrol.

As the course is taught and assessed in English, applicants must have a good command of spoken and written English. We do not enforce testing but suggest a minimum British Council IELTS grade requirement of 6.5 or equivalent. Equivalent experience may include the successful completion of a degree or other accredited postgraduate qualification in the English language or a significant period of residence/work placement in an English-speaking country.

Fees overview:

- › **Annual enrolment fee for 2026:** £4,315 + VAT
- › **Total fees:** From £12,945 + VAT
- › Fees can be paid annually prior to course commencement, or as a monthly direct debit
- › For the first three years of study, the annual enrolment fee applies. If studies are extended, then only a significantly reduced enrolment is payable in years 4 and 5.
